

**CORPORATION OF THE TOWNSHIP OF  
KILLALOE, HAGARTY AND RICHARDS  
BY-LAW NO. 43-2013**

**BEING A BY-LAW TO PROVIDE FOR THE STOPPING UP AND CLOSING OF PART OF AN ALLOWANCE FOR ROAD ALONG ROUND LAKE IN FRONT OF PART OF LOT 11, CONCESSION 2, IN THE GEOGRAPHIC TOWNSHIP OF RICHARDS, IN THE TOWNSHIP OF KILLALOE, HAGARTY AND RICHARDS, COUNTY OF RENFREW, BEING PARTS 3, 4 and 5 ON REFERENCE PLAN 49R-18181, BEING PART OF PIN 57535-0113(LT), PART 4 ON REFERENCE PLAN 49R-18181 BEING SUBJECT TO A FLOODING EASEMENT IN FAVOUR OF RENFREW POWER GENERATION INCORPORATED, AND FOR THE CONVEYANCE OF THE SAID PARTS OF THE ALLOWANCE FOR ROAD TO THE ADJOINING LAND OWNER(S) THEREOF.**

WHEREAS the Corporation of the Township of Killaloe, Hagarty & Richards is the legal owner of that part of the road allowance in along Round Lake in front of Lot 11, Concession 2, Geographic Township of Richards, Municipality of Killaloe, Hagarty and Richards County of Renfrew and Province of Ontario, more particularly described in Schedule "A" hereto attached;

AND WHEREAS the Council of the Corporation of the Township of Killaloe, Hagarty and Richards, pursuant to the powers vested in it under the Municipal Act 2001, deems it necessary and advisable to stop up and close that part of the original road allowance more particularly described in Schedule "A" hereto attached;

AND WHEREAS the Corporation of the Township of Killaloe, Hagarty and Richards deems it necessary and advisable to convey the aforesaid lands, more particularly described in Schedule "A" hereto attached, to the adjoining land owners thereof pursuant to the provisions of the Municipal Act 2001;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF KILLALOE, HAGARTY AND RICHARDS ENACTS AS FOLLOWS:

1. Pursuant to the Municipal Act, 2001 that part of the road allowance more particularly described in Schedule "A" hereto attached be and the same is hereby closed and stopped up.
2. That the Mayor and Clerk be and they are hereby authorized to convey the aforesaid lands to the adjoining land owners thereof pursuant to the provisions of the Municipal Act, 2001, in consideration of the payment by the aforesaid adjoining land owners to the Municipality of the Township of Killaloe, Hagarty and Richards the sum of the Townships' legal fees and disbursements in conjunction with the same.
3. That the Mayor and Clerk be and they are hereby authorized to execute any documents necessary for the transfer of the aforesaid lands to the adjacent land owners thereof and to affix the corporate seal thereto.
4. This by-law shall come into force and take effect upon the final passing thereof.

Read a first and second time this 19<sup>th</sup> day of November, 2013.

Read a third time and finally passed this 7<sup>th</sup> day of January, 2014.
