

**CORPORATION OF THE TOWNSHIP OF  
KILLALOE, HAGARTY AND RICHARDS**

**BY-LAW NO. 14-2022**

**BEING A BY-LAW TO PROVIDE FOR THE STOPPING UP AND CLOSING OF PART OF AN ALLOWANCE FOR ROAD ALONG GOLDEN LAKE, FRONTING LOT 1, CONCESSION 5 BEING:**

**Part of original shore road allowance fronting Lot 1 Concession 5, being Part 1 Plan 49R-20033, Township of Killaloe, Hagarty and Richards, County of Renfrew.**

**AND FOR THE CONVEYANCE OF THE SAID PARTS OF THE ALLOWANCE FOR ROAD TO THE ADJOINING LANDOWNER(S) THEREOF.**

WHEREAS the Corporation of the Township of Killaloe, Hagarty and Richards is the legal owner of that part of the road allowance along Golden Lake fronting Lot 1, Concession 5 Geographic Township of Hagarty, Municipality of Killaloe, Hagarty and Richards County of Renfrew and Province of Ontario, more particularly described in Schedule "A" hereto attached;

AND WHEREAS the Council of the Corporation of the Township of Killaloe, Hagarty and Richards, pursuant to the powers vested in it under the Municipal Act 2001, deems it necessary and advisable to stop up and close that part of the original road allowance more particularly described in Schedule "A" hereto attached;

AND WHEREAS the Corporation of the Township of Killaloe, Hagarty and Richards deems it necessary and advisable to convey the aforesaid lands, more particularly described in Schedule "A" hereto attached, to the adjoining landowners thereof pursuant to the provisions of the Municipal Act 2001;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF KILLALOE, HAGARTY AND RICHARDS ENACTS AS FOLLOWS:

1. Pursuant to the Municipal Act, 2001 that part of the road allowance more particularly described in Schedule "A" hereto attached be and the same is hereby closed and stopped up.
2. That the Mayor and Clerk be, and they are hereby authorized to convey the aforesaid lands to the adjoining landowners thereof pursuant to the provisions of the Municipal Act, 2001, in consideration of the payment by the aforesaid adjoining landowners to the Municipality of the Township of Killaloe, Hagarty and Richards the sum of the Townships' legal fees and disbursements in conjunction with the same.
3. That the Mayor and Clerk be, and they are hereby authorized to execute any documents necessary for the transfer of the aforesaid lands to the adjacent landowners thereof and to affix the corporate seal thereto.
4. This by-law shall come into force and take effect upon the final passing thereof.
