Council for the Township of Killaloe, Hagarty and Richards met on the above date with Mayor Janice Tiedje and Councillors Debbie Peplinskie, Stanley Pecoskie, Carl Kuehl, Ted Browne, Brian Pecoskie and John Jeffrey in attendance. Also in attendance were Fire Chief Bob Gareau, Works Superintendent Dean Holly and Community Development Officer Chris Neff.

Motion to approve minutes of regular meeting held on February 1, 2022, open and closed session. Carried.

Reports:

Fire Chief: Fire Chief Bob Gareau was present and was invited to give his report. He reported that KHR fire department responded to 2 fire callouts, and he attended three special event meetings on the new Mandatory Firefighter Certification Program. Chief Gareau provided a summary on the new certification requirements being proposed and the timelines associated. Mayor Tiedje and CAO Clerk-Treasurer Sheridan to sit in on a technical briefing on the new regulations. Fire Chief Gareau has provided his comments to the OFM and will provide a report for Council. Fire Chief Gareau stated he will be reinstating training which had to be cancelled due to COVID-19 restrictions as of March 8, 2022. Fire Chief Gareau provided current COVID-19 statistics locally, provincially, nationally and internationally. Council thanked Chief Gareau for his report.

Works Superintendent: Works Superintendent Dean Holly was present and was invited to present his report. Mr. Holly stated regular winter maintenance continues including sanding, salting, culvert thawing and snow removal in the Village of Killaloe. Works department continues with harvesting wood for the outdoor furnace. Mr. Holly advised he has reached out to County of Renfrew Director Public Works Lee Perkins with respect to the outdoor weather monitoring antenna at the by-pass and will bring costing for council's consideration. Mr. Holly advised that the new plow truck will probably be built within the next month or so and expected delivery date may be late June or July. Council reviewed a request from Bradley Law for the township to enact a by-law to transfer title of the travelled portion of Cardinal road which goes through the property of the landowner. Council discussed this matter and instructed the CAO Clerk-Treasurer to contact our municipal lawyer to proceed with this request and that all costs are borne by the landowner.

Item #5 – Eat & Greet - Scheduled on April 29, 2022.

Item #6 – Environmental Action Tour April 30, 2022 – Council approved this event and budget of \$6,000.

Item #7 – Other Budget Pre-Approvals – Irish Jig Jam \$325, Easter Candy Land \$1,000, Volunteer Appreciation \$1,000, Canada day \$20,000 and Irish Gathering \$30,000.

Item #8 – Other updates included Rural Community Cooperative meeting, RC recreation meeting and COVID-19 deadlines, updates and EOCG meetings. Council discussed reviving the annual Loggers Event and members agreed to meet on February 22, 2022 on this matter. Council thanked Community Development Officer Neff for his report at which time he left the meeting.

CAO Clerk-Treasurer Sheridan brought forth a letter from Mr. Todd White from CRINS looking for direction from Council on the application process and their position with respect to the application fee. Council was unanimous that any telecommunication carrier application received by CRINS for site selection and review in the Township of Killaloe, Hagarty and Richards will not proceed unless the application fee is paid in full.

- Information explicitly supplied in confidence to the municipality or local board by Canada, a province or territory or a Crown agency of any of them;
- A trade secret or scientific, technical, commercial or financial or labour relations information supplied in confidence to the municipality or local board, which, if disclosed, could reasonably be expected to significantly prejudice the competitive position or interfere significantly with the contractual or other negotiations of a person, group of persons, or organization;
- A trade secret or scientific, technical, commercial or financial information that belongs to the municipality or local board and has monetary value or potential monetary value; or
- A position, plan, procedure, criteria or instruction to be applied to any negotiations carried on or to be carried on by or on behalf of the municipality or local board;
- A request under the *Municipal Freedom of Information and Protection of Privacy Act*, if the council, board, commission or other body is the head of an institution for the purposes of that Act; or
- An ongoing investigation respecting the municipality, a local board or a municipally controlled corporation by the Ombudsman appointed under the *Ombudsman Act*, an Ombudsman referred to in subsection 223.13 (1) of this Act, or the investigator referred to in subsection 239.2 (1).;
- Education or training sessions for council or local board or a committee of either or them, if the meeting is held for that purpose of educating or training the members, and if at the meeting, no member discusses or otherwise deals with any matter in a way that materially advances the business or decision-making of the council, local board or committee.
