Council for the Township of Killaloe, Hagarty and Richards met on the above date with Mayor Janice Tiedje and Councillors Debbie Peplinskie, Stanley Pecoskie, Carl Kuehl, Ted Browne and John Jeffrey in attendance. Also in attendance were Fire Chief Bob Gareau, Works Superintendent Dean Holly and Community Development Officer Chris Neff.

Mayor Tiedje called the meeting to order.

Delegation:

Mayor Tiedje welcomed Lynne Postill and Bruce Burnett and introduced council and staff. Mayor Tiedje provided a brief history and actions taken by council on the properties on Queen Street which included removal of federal and provincial liens, ensuring the building was safely boarded up, listing the property for tax sale and finally, vesting the property in the municipalities name. Mayor Tiedje stated that Council has been dealing with this property for several years and provided detailed history to where today this property is now in the ownership of the municipality. She stated that this process took time and the municipality had to follow all legal deadlines and time constraints. She stated council was very cognizant of the costs and wanted to minimize the burden to all the ratepayers of Killaloe, Hagarty and Richards. She advised that council has instructed staff to examine all options for this property and bring recommendations in a report back to council for consideration. Mr. Burnett and Ms. Postill thanked Mayor Tiedje for an updated account and stated that they were unaware of the legalities and challenges which had to be undertaken and hoped that a decision on this property would be made soon. Mayor Tiedje reiterated that Council will be reviewing all options presented with a decision rendered relatively soon. Council thanked Ms. Postill and Mr. Burnett for their attendance, at which time they left the meeting.

- A position, plan, procedure, criteria or instruction to be applied to any negotiations carried on or to be carried on by or on behalf of the municipality or local board;
- A request under the *Municipal Freedom of Information and Protection of Privacy Act*, if the council, board, commission or other body is the head of an institution for the purposes of that Act; or
- An ongoing investigation respecting the municipality, a local board or a municipally controlled corporation by the Ombudsman appointed under the *Ombudsman Act*, an Ombudsman referred to in subsection 223.13 (1) of this Act, or the investigator referred to in subsection 239.2 (1).;
- Education or training sessions for council or local board or a committee of either or them, if the meeting is held for that purpose of educating or training the members, and if at the meeting, no member discusses or otherwise deals with any matter in a way that materially advances the business or decision-making of the council, local board or committee. Fire Chief: Fire Chief Bob Gareau was present and was invited to present his report. Activities since April 19, 2022 – responded to fire calls on April 28, May 2 and May 7, 2022, ongoing activities included truck & equipment checks and installations of the new fire ban signage. Recent events included Senior Management meetings, presentation on Human trafficking, attendance at the OAFCA trade show in Toronto. Fire Chief Gareau provided a list of upcoming events, training undertaken and scheduled training dates. CEMC activities included Spring Freshet meetings, 2021 compliance letter was received and a capital sector meeting in person meeting is scheduled in June. COVID-19 statistical report since April 19, 2022 was received. Council thanked Fire Chief Gareau for his report, at which time he left the meeting.

Works Superintendent: Works Superintendent Dean Holly was present and was invited to present his report. Works department continue with regular road maintenance including grading on various roads, cold patching, as well as sweeping. Mr. Holly stated half loads will be off on Monday May 16, 2022. Mr. Holly stated that the 2009 truck scheduled for disposal once the new plow truck arrives is no longer road worthy and requested and received permission to advertise this truck on Gov Deals. Calcium is scheduled to be delivered this week, some of the employees will be participating in a propane refresher course in Bonnechere Valley and requested and received approval to reopen the Second Chance building at the land fill sites. Staff continue to clean up at the landfill sites and still waiting for confirmation from Ottawa Valley Waste Recovery on available compost.

Councillor Pecoskie Stanley brought forth a complaint from Lorne Scheuneman that needles/brush have been disposed on their property on Sunrise Road. Works Superintendent Holly will check this out.
