Council for the Township of Killaloe, Hagarty and Richards met on the above date with Mayor David Mayville and Councillors Harold Lavigne, Bil Smith, Maureen MacMillan, Carl Kuehl, Ted Browne and Brian Pecoskie in attendance.

## **Call to Order:**

Mayor Mayville chaired the meeting which he opened and called to order.

### **First Nations Land Acknowledgement:**

First Nations Land Acknowledgement read by Mayor Mayville.

# **Moment of Silent Reflection:**

Mayor Mayville requested a moment of silent reflection.

## **Mayor's Address:**

Mayor Mayville reported that he recently attended a County Council meeting, which included the Development and Property Committee as well as the Operations Committee. Mayor Mayville also noted that he participated in the Shrine Hill Day of Mourning, an Irish Gathering planning meeting, Mark Wilmer's Celebration of Life, the Environmental Action Tour, and a Finance Committee meeting. And lastly, Mayor Mayville provided an update on the freshet situation as it pertains to Round Lake and Golden Lake.

## **Pecuniary/Financial Interest:**

No pecuniary/financial interest was declared.

#### **Delegations:**

Nirvana Fernandz, CEO of DNR Productions and Board of Director member for the Killaloe Craft Community Fair Taisha Levy, was in attendance and invited to address Council. Mr. Fernandz presented a proposal, outlining plans for a large-scale music, art, and wellness festival within the Township. Mr. Fernandz presentation covered key aspects including logistics, safety measures, and potential impacts on the community. Council discussed the proposal and advised that additional time is needed to consider the information provided and conduct further research before rendering a decision.

Council thanked Mr. Fernandz for his presentation at which time he and Taisha Levy left the meeting.

Brian Whiffin, President of the Killaloe and Area Pickleball Club (KAPC), was in attendance and invited to address Council. Mr. Whiffin advised that the KAPC is seeking a facility usage agreement with the Township and requested support in several areas: spring-cleaning services to remove debris and accumulated gravel/sand, provision of equipment such as leaf blowers to assist with ongoing court maintenance, exploration of both short-term (e.g., pumps, shop vacuums) and long-term (e.g., grading, drainage installation) solutions for drainage issues, and the establishment of a liaison committee to support ongoing communication and collaboration. Council discussed and approved the request to support a spring-cleaning service provided by the Township, approved to explore solutions for drainage and approved for Community Development Coordinator Colton Charbonneau to serve as the primary Township liaison with no liaison committee to be established. Council also advised that Facilities/Asset Manager Dale Thompson is to be contacted in the event repairs are needed to the facility. Community Development Coordinator Charbonneau noted that the facility usage agreement is almost complete and will be provided to Council for comment.

#### **Reports:**

Community Development Coordinator: Community Development Coordinator Colton Charbonneau was in attendance and invited to give his report. Community Development Coordinator Charbonneau provided an update on his recent activities, including his attendance at the Teeny Tiny Summit. Community Development Coordinator Charbonneau also reported on the success of the Environmental Action Tour, noting that 120 bags of refuse was collected and recommended a shift toward encouraging year-round litter collection. Additionally, Community Development Coordinator Charbonneau informed Council that the Township had successfully secured \$6,000 from the Celebrate Canada Grant fund and \$3,868.72 from the Experience Ontario Grant fund to support Canada Day.

Councillor Pecoskie expressed support for the idea of promoting year-round litter collection.

Councillor Smith updated Council on his attendance at the Teeny Tiny Summit.

Council thanked Community Development Coordinator Charbonneau for his report at which time he left the meeting.

#### **New Business:**

Councillor Brian Pecoskie reported on the Strong Mayor Powers and indicated that he asked staff to prepare a resolution expressing opposition to these powers. Councillor Pecoskie also requested a recoded vote.

Moved by Brian Pecoskie Seconded by Ted Browne

WHEREAS the Province of Ontario has designated the Township of Killaloe, Hagarty and Richards as a "Strong Mayor" municipality, granting enhanced powers to the Mayor effective May 1, 2025;

AND WHEREAS these Strong Mayor powers significantly alter the traditional governance structure at the municipal level, diminishing the role of Council in decision-making and weakening the foundational democratic principle of majority rule;

AND WHEREAS the Township of Killaloe, Hagarty and Richards has a long-standing tradition of collaborative, transparent, and accountable local governance, rooted in open Council debate and collective decision-making;

AND WHEREAS elected officials and members of the public across the province have raised serious concerns about the imposition of these powers without sufficient consultation or demonstrated need;

AND WHEREAS the Township neither requested nor expressed interest in being designated under the Strong Mayor framework and firmly opposes its application within the community;

AND WHEREAS a growing number of municipalities and elected representatives across Ontario are questioning the appropriateness of the Strong Mayor model and advocating for its reconsideration or repeal in defense of balanced and representative local governance;

NOW THEREFORE BE IT RESOLVED that the Council of the Corporation of the Township of Killaloe, Hagarty and Richards formally requests that the Premier of Ontario and the Minister of Municipal Affairs and Housing immediately remove the Township from the list of municipalities designated under the Strong Mayor legislation;

AND BE IT FURTHER RESOLVED that a copy of this resolution be forwarded to the Premier of Ontario; the Minister of Municipal Affairs and Housing; MPP Billy Denault; all Ontario municipalities; the Association of Municipal Managers, Clerks and Treasurers of Ontario (AMCTO); and the Association of Municipalities of Ontario (AMO) for their information and support. Carried.

Councillor Smith advised that Council had signed a letter opposing the strong mayor powers and he submitted on behalf of Council and received a response from MMAH. Councillor Smith indicated that he would forward to all of Council and asked that it be included in Council agenda packages for the next meeting. Council had no objections to this request.

CAO/Clerk – Treasurer advised that the County of Renfrew is proposing an amendment to their Official Plan to permit their Council to provide grants and/or loans to support local Community Improvement Plan incentives. CAO/Clerk - Treasurer Gorgerat indicated that an amendment is being sought to establish a regional incentive program entitled Helping Your Place Excel (HYPE) and that the HYPE programs key focus areas include agriculture and Agri-tourism, brownfield redevelopment, affordable housing and secondary dwellings, energy efficient and environmental enhancements, accessibility improvements, commercial, institutional and industrial development and trail improvements. CAO/Clerk - Treasurer Gorgerat advised that only municipalities who have a CIP are eligible for this incentive and currently 7 of the 17 municipalities in Renfrew County have CIP's, which include Arnprior, Laurentian Valley, Whitewater Region, Bonnechere Valley, Petawawa, Deep River and Renfrew with the remaining 10 municipalities, including Killaloe, Hagarty and Richards, not eligible for this incentive program. CAO/Clerk – Treasurer Gorgerat advised that the County is holding a Public Meeting on June 12, 2025 at 3:00 pm at the County Administration building at 9 International Drive to inform the public of the proposed Official Plan amendment. CAO/Clerk - Treasurer Gorgerat indicated that the County is seeking agency responses through the "Notice to Public Bodies" and inquired direction on how Council would like to respond. Council discussed and advised that they require additional information regarding CIP's before rendering a decision.

Councillor Smith spoke to the matter involving the Hoch Farm sign and the Killaloe Heritage and Ecology Society. Councillor Smith advised that the Society would like the sign, which is currently still in the Township's possession to be used by CRC as part of their "good food" project at KPP. Council had no objection to this request.

Council approved Councillor Smith and Mayor Mayville's attendance at the AMO Good Governance Session which is scheduled to take place on June 11th in Almonte.

Councillor Lavigne reported receiving several calls regarding the windstorm that passed through Pine Point and asked if Council would consider approving a free brush collection day for those only on Pine Point Lane impacted by the storm. Council had no objections to this request.

Mayor Mayville asked and received approval to replace the "Yield to Flashing Green Light Firefighter" signage with larger ones, at an estimated cost of \$120.00.

Mayor Mayville asked and received approval for himself and Councillor Pecoskie to attend the Upper Ottawa Valley Chambers of Commerce Business Excellence Awards Gala where former MPP John Yakabuski will be honored with the 2025 Lifetime Achievement Award at a cost of \$145.00 per person.

Councillor Browne informed Council that the 2nd Chance building has been closed since COVID, and he has received complaints about its continued closure. Council discussed the matter and agreed that further discussions are needed before making a decision on whether to reopen it.
